## CALL TO FRIENDSHIP WEBSITE DATA PRIVACY POLICY

As the Call to Friendship Association (“**Association**” or “**CALL TO FRIENDSHIP**”) it is our utmost priority to have your private data processed and protected in full compliance with the Protection of Private Data Law no 6698 and all relevant secondary regulations (“**Privacy Law Legislation**”) when you visit our legal website <https://www.calltofriendship.org>.

Within the framework of our Association’s liability of disclosure in compliance with the Privacy Law legislation, we would like to fully inform our visitors of <https://www.calltofriendship.org> via this CALL TO FRIENDSHIP Website Privacy Law Informatory Statement (“**Statement**”).

### **How and to what purpose do we collect and process your data?**

During your visit to <https://www.calltofriendship.org> your personal data stated below, including your traffic data, are processed electronically and physically in writing, automatically and non-automatically in relevance to, limited with and measurable by the purposes also stated below, in compliance with the Privacy Law legislation.

### **With whom are your personal data shared and to what purpose?**

We are also sharing your personal data stated in this Statement with external service providers (IT specialists, database providers, backup and recovery experts etc.) in relevance to, limited with and measurable by the execution of the purposes of our Association as well as the purposes stated herein, in compliance with the Privacy Law legislation.

The third parties with whom we share your data are liable in relation to our agreement to process and protect your personal data in relevance to, limited with and measurable by the purposes of sharing unless otherwise dictated by the Privacy Law legislation, under the supervision of CALL TO FRIENDSHIP.

And finally, in order to fulfill our legal obligations and liabilities, we share your personal data with governmental and judiciary bodies and offices in compliance with the Privacy Law legislation.

### **Are your personal data being transferred out of Country?**

Our Association does not transfer your personal data which are collected via the website to third parties resident in other countries.

## **The safety, storage and deletion of your personal data**

Our Association has a high awareness on ensuring the safety and privacy of personal data. In this direction, CALL TO FRIENDSHIP is processing the personal data of the website visitors stated in this Statement by ensuring the safety of the data in question in compliance mainly with the Privacy Law legislation and also with the Privacy Law Procedure – Personal Data Storage and Deletion Policy of our Association.

Your personal data are stored and retained within the time limits necessary for the purposes of data processing stated in this Statement as well as the legal period of limitation stated in the legal regulations. At the end of the said time ad period CALL TO FRIENDSHIP deletes, eliminates and anonymizes your personal data in compliance with the Personal Data Storage and Deletion Policy.

Our Association takes all technical and managerial measures necessary as per the Privacy Law legislation in order to prevent unauthorized access to, or erroneous processing, disclosing and unlawful alteration/deletion of your personal data as well as to ensure the protection and safety thereof. In cases deemed necessary by the Privacy Law legislation, CALL TO FRIENDSHIP will notify both you and the Personal Data Protection Board immediately.

## **Your Right to Information**

Within the framework of Article 11 of the Data Privacy Law, we inform you that you have the right to apply to our Association and request the following pertaining to your personal data **(i)** to learn whether these data have been processed, **(ii)** if so, to be informed thereof and to learn the purpose for such processing and compliance to that purpose, **(iii)** to learn 3<sup>rd</sup> parties to whom it has been transferred within/out of the country, to correct the data in case of insufficient/erroneous processing, **(iv)** to delete/eliminate the data within the conditions set forth in Article 7 of the Data Privacy Law, **(v)** to inform third parties to whom your data have been transferred of your requests for deletion/elimination of your personal data as well as the correction of insufficient/erroneous processing be deleted and eliminated within the scope of Article 7 of the Data Privacy Law, **(vi)** to object to any conclusion adversely against you based on the exclusive analysis of your data with automated systems adverse conclusion, **(vii)** to be compensated for your loss in case you face such loss due to unlawful processing of your data.
